

Privacy Policy

Your privacy is important to USA Truck Inc. (“USAT”) while you are visiting our website at www.usa-truck.com and all associated sites including but not limited to www.USATLogistics.com and www.DriveUSATruck.com (“the Site”). This Website Privacy Policy will provide you information as to how USAT treats the information we receive about you.

INFORMATION GATHERED OR RECEIVED

Some portions of the Site do not require you reveal any information about yourself. However, our servers will collect information such as the HTTP request header, IP address, and browser information of visitors to allow us to measure the use and improve usage of the Site. The Site does not respond to Do Not Track signals.

For use of some portions of the Site, USAT may need personal information from you, such as your name, address, and contact information, to provide services and products you request. The personal information collected is used only by USAT and its partners, service providers, and affiliates to provide you services, respond to your inquiry, or grant you access to specific account information. To create a customer login account, seek to become an agent or request a quote, USAT will collect your email address, first and last name, title, company name, address, and phone number. It is at your sole discretion the amount of personal information you disclose to USAT. The provision of the information is not mandatory but will affect the extent to which USAT can offer services, products, and responses to your inquiries. You may access and control your personal information through your user account management link.

USE AND DISCLOSURE OF PERSONAL INFORMATION

The information and data collected from you for statistical purposes may be stored by USAT indefinitely. USAT may disclose aggregated data and statistics to describe the Site to third parties and for other lawful purposes. If you create a user account, you agree USAT may occasionally use your name and email address to send you notifications regarding the Site or USAT. To unsubscribe

from promotional emails, you may do so by editing the notification settings in your account or by following the unsubscribe instructions included in each email.

USAT may disclose your personal information as required by law, to enforce our Website Terms of Use and Website Privacy Policy, or to fulfill your orders. Additionally, USAT may disclose your information as part of any merger, sale, or acquisition of some or all of USAT or its assets.

ACCESS TO YOUR PERSONAL INFORMATION

Upon email request to Helpdesk@usa-truck.com and subject to your provision of proof of your identity, USAT will provide you with a copy of the personal data gathered about you without any charge. You may contest the data about you and, where appropriate, have the data erased, corrected, or completed.
