<sup>7</sup> **Fix day to be agreed** consists in the distribution of general merchandise consignments with the delivery date agreed by DB SCHENKER with the consignee (max. 3 days longer than DB SCHENKERsystem delivery time).

<sup>8</sup> **Fix day 10 or Fix day 13** options consists in the distribution of groupage consignments with the delivery before 10 a.m. (option Fix day 10) or before 1 p.m. (option Fix day 13) local time, with the delivery on the business day agreed with the Contracting Entity (max. 3 days longer than DB SCHENKERsystem delivery time).

<sup>9</sup> **premium10 or premium13** options consists in the distribution of groupage consignments with the guaranteed delivery before 10 a.m. (option premium10) or before 1 p.m. (option premium13) local time, as soon as possible, according to the delivery schedule for the specific product. Those options are available only as part of DB SCHENKERsystem premium service, and for a limited scope of postal codes as specified by DB SCHENKER.

<sup>15</sup> **Pre-Notice Pick-up** – consists of notifying the sender of the expected collection, provided that Schenker is not responsible for accepting the notification by the sender and that it is not possible to change the collection time when implementing this service.

<sup>16</sup> **Pre-Notice delivery** is a notification to the recipient of the expected delivery, provided that Schenker is not responsible for accepting the notification by the recipient and that it is not possible to change the delivery date when implementing the service.

<sup>17</sup> **Fix Day Pick-up** option – Distribution of DB SCHENKERpart load and DB SCHENKERfull load with a pickup date on a specified working day

<sup>18</sup> **Fix Day delivery** option – Distribution of DB SCHENKERpart load and DB SCHENKERfull load shipments with a delivery date on a specified working day.

<sup>19</sup> **Time window Pick-up** option – Distribution of DB SCHENKERpart load and DB SCHENKERfull load for selecting a specific timing window for pickup, between 09:00 and 12:00, which is referred to as "morning" or between 13:00 and 16:00, which is referred to as "afternoon".

<sup>20</sup> **Time window delivery** option – Distribution of DB SCHENKERpart load and DB SCHENKERfull load to select a specific timing window for shipment delivery between 09:00 and 12:00, which is known as "Morning" or between 13:00 and 16:00 Defined as "Afternoon".

<sup>21</sup> **Same Day Collection** option – Distribution of DB SCHENKERpart load and DB SCHENKERfull load shipments with the delivery deadline on the date of the order. This option is only available on request and cannot be commissioned via e-Schenker applications. The customer is obliged to contact the Department in order to determine the delivery capacity and delivery time.

<sup>25</sup> **Eco neutral** option - a service that includes the estimation of the carbon footprint related to the distribution of the shipment for which the option has been selected and the offsetting (offsetting) of the estimated carbon dioxide (CO2) emissions by financing, in cooperation with the atmfair gGmbH based in Berlin (hereinafter Atmosfair) CO2 emission reduction projects in developing countries, operating under the UN Clean Development Mechanism, for an additional fee ("Eco neutral fee").

DB SCHENKER will provide the recipient with a link to the website via SMS in order to determine the delivery date (max. 3 days longer than DB SCHENKERsystem delivery time).
